  - Roman Shades
  - Drapery Panels – our Sizing Solutions tables will determine what you'll need to cover your windows
  - Pole Mounted Valances
  - Board Mounted Valances
  - Upholstered Cornice Boards
- Select Your Fabric & Note the Price Tier (1, 2, or 3)
- Select Your Lining
  - Standard Lining
  - Thermal Sateen Lining - recommended for Shantung Antique Satin, Cohiba, Silk, Echo, and Slalom
  - Standard Room Darkening Lining – recommended for Shantung Antique Satin, Cohiba, Silk, Echo, and Slalom
- Select Your Decorative Hardware
  - Choose wood, metal, bamboo, or basic white hardware
  - Choose your rod pocket size if applicable
    - 1-1/2" pocket is best for 3/4" diameter decorative hardware

    - All Phase II hardware in this program requires a 3" pocket

- Please allow 3 to 5 days for delivery

### Lead Time

- Custom orders will be shipped via UPS to arrive at the customer's home in 21 days or less
- Standard Lead Time: 24 hour cancellation period + 10 days in house + 5 days in transit + weekends

### Return Policy

- Manufacturer Error: Phase II will refund 100% of the original order or remake the order at no cost
- Customer Error / Store Error: Phase II will charge 100% of original order, 75% of reorder
- Freight Damage: If damage is obvious, customer should refuse delivery and contact their retail associate immediately. If damage is concealed, it must be reported within 90 days of receipt – contact Texton to reorder – Texton/Phase II will file a claim with the carrier.
- Changes / Cancellations: Standard policy applies. All window coverings are custom fabricated to your specifications. Made-to-Measure window coverings CANNOT be returned unless there is a manufacturer's defect. Any changes or cancellations MUST occur within 24 hours of the initial order.

# Limited Lifetime Warranty

---

The enclosed product is warranted to the original residential retail purchaser as long as the product remains in the original window.

## Covered:

Lifetime: Entire product against manufacturing defects (i.e. a flaw in the product design, materials, or workmanship that causes the product to no longer function)

5 years: All fabric.

5 years: all Somfy motors and accessories.

## Not Covered:

Normal Wear and Tear

Any product that fails due to:

- abuse • exposure to salt air • improper installation • accident • extraordinary use
- improper operation • alterations • improper cleaning • misapplication
- damage from pests/insects/pets • improper handling • misuse

Costs associated with:

- product removal • transportation to and from the retailer • brand label removal
- product re-measure • incidental or consequential damages • product reinstallation
- shipping

In the event there are multiple blinds/shades in the same room, only the defective blind/shade will be replaced.

## To Report Shipping Damage:

If damage occurred during shipping, call place of purchase and report within 7 calendar days or else you may be denied credit for your damaged product.

## To Obtain Service:

If you suspect this Texton product has a manufacturing defect in materials or workmanship:

1. Locate the sales receipt
2. Call place of purchase

Any unauthorized returns will not be accepted.

## Warranty Remedy:

THIS SHALL BE YOUR SOLE REMEDY UNDER THIS LIMITED WARRANTY. If this product is found to have a manufacturing defect in materials or workmanship, we will (at our discretion) do one of the following:

- repair the product • replace the product • refund the cost of the product upon inspection.

Colors vary from lot to lot and may not exactly match sample swatch or previous purchases.

Discontinued items or color selections will be replaced with the closest equivalent current product.

## YOUR RIGHTS UNDER STATE LAW:

This lifetime limited warranty gives you specific legal rights, and you may have other rights, which vary from state to state. Some states do not allow limitations on how long a warranty lasts, so the above limitations may not apply to you.
